

## Alcolocks: a life saving technology

*Safe & Sober Talk in the European Parliament on 6 October 2010, 12:00 -14:30*

In 2007 ETSC started a campaign on drink driving, called "Safe & Sober". In light of the European Union's road safety target to halve road deaths by 2010, the objective of this activity is to raise awareness amongst policy makers, the private sector as well as key opinion leaders for a systemic approach to reduce alcohol misuse in road transport, especially in commercial and passenger road transport. Alcohol interlocks have become an important tool of the national strategy on reducing deaths from drink driving in several Member States, yet, we are far from a co-ordinated approach at the EU level, which could be beneficial for all EU countries.

This event jointly organised by the MHF and the ETSC is an occasion to discuss the role of alcohol interlocks in the new EU road safety strategy for 2011-2020. It will be held on the 6<sup>th</sup> of October 2010 in the European Parliament, in Brussels. The event is organised as a seated lunch at the private Salon of the Member's restaurant and co-hosted by MEPs Anna Hedh and Dieter-Lebrecht Koch.

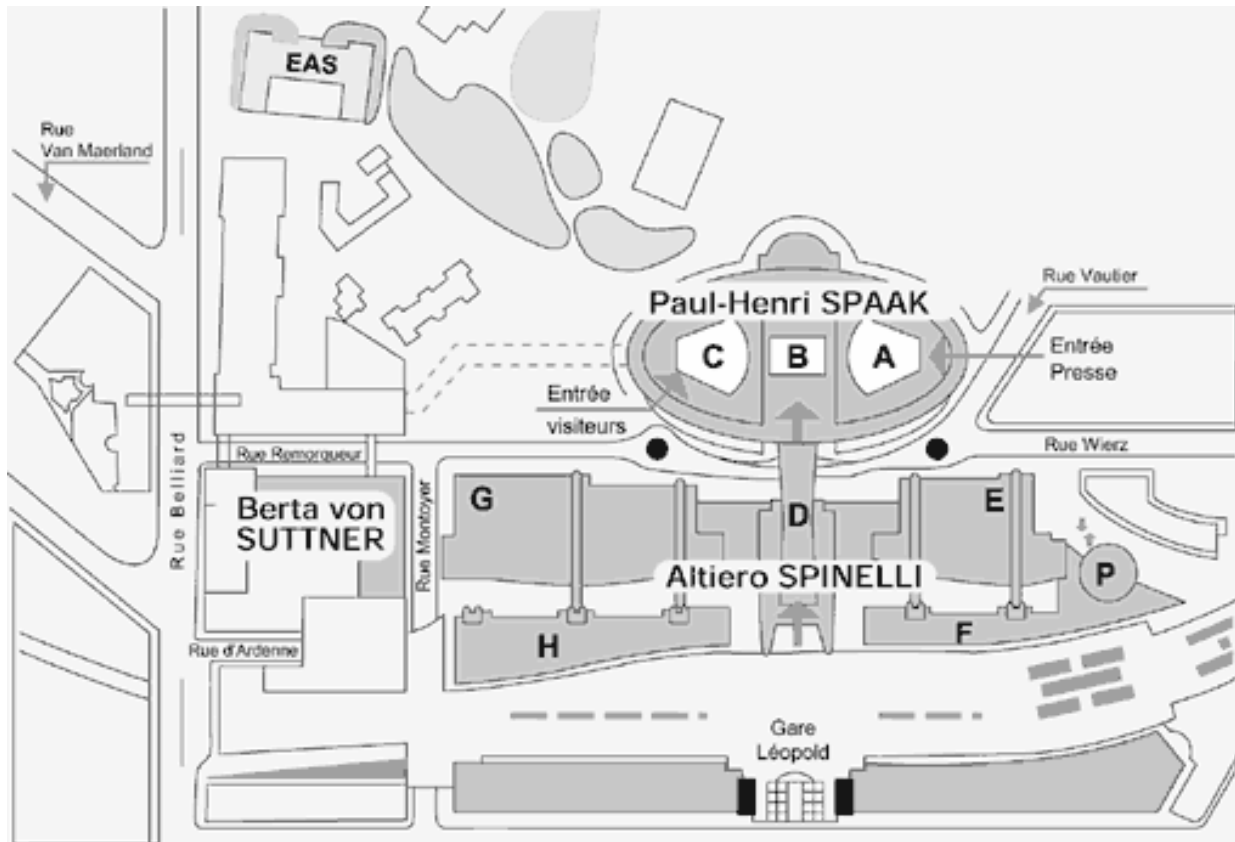
