#### " Press visit - Safe and sober! Drink Driving checks in Germany"

When: Friday 22 September 2006,

Where: Aachen region, North Rhine-Westphalia (Germany)

Drink Driving is the second greatest cause of road deaths in the EU. If 2-3% of journeys are associated with an illegal BAC, this affects 30-40% of road deaths, many of them innocent people. Police drink driving enforcement has been proven to be an effective tool to promote a sober and safe way of driving<sup>(1)</sup>. It is therefore crucial to carry out intensive and widespread alcohol checks by the police.

Although the number of drink driving related deaths and injuries has dropped in the last decade in Germany (-14% from 2003 to 2004), there is still a long way to go to take drink drivers off the road. Also, random breath testing has proven to be a very effective means of deterring drink-driving in many European countries. Unfortunately, as the case for some other EU countries, Germany has not yet introduced such a measure.

A public consultation<sup>(2)</sup> by the European Commission on a Directive to enhance co-operation on the cross border enforcement of traffic offences (including drink driving) is around the corner. ETSC<sup>(3)</sup> stresses for the need to ensure that all Member States are aiming to achieve high standards in the areas of speeding, drink driving and seat belt use according to the best practice set out in the EC Recommendation on enforcement.
